The Executive Director and Interim Chief Executive Officer participated in the Florida Children's Coalition Rally in Tally December 4-6th. The event provides child welfare organization, the Department of Children and Families, community leaders, business leaders, elected officials and child advocates, youth in care and their foster families from throughout the state the opportunity to gather and discuss legislative priorities impacting children and families in Florida before the upcoming 2018 session. During our visit we had the opportunity to meet with several members of the Brevard delegation and the replication site delegation including Representative Goodson, Representative Plasencia, Representative Santiago, and Senator Hutson. White visiting the state capital, HB 3963 - National Center for Innovation and Excellence - Brevard CARES Expansion was filed by Representative Plasencia. This appropriations bill request \$150,000 to support the full C.A.R.E.S. Program replication in Volusia and Flagler Counties.

Brevard C.A.R.E.S. hosted our Winter Wonderland event for the families we serve on December 13th. The event continues to be well attended and enjoyed by attendees, volunteers and staff members alike. This year we had cookie decorating, rock painting, and tile design stations for the children to participate in while the parents went to collect gifts from Santa's Workshop. Brevard C.A.R.E.S. will serve as the government/agency champion for the implementation in Brevard. In January our Community Services Program Manager will attend the Open Table train the trainer to help ensure sustainability in the community and I will be working with Vision Orlando and Open Table to meet with different faith based leaders throughout the community for mission introductions and exploratory meetings.
